Pendulum's Enterprise Risk Management System is a web-based program designed to identify, assess, prioritize, and manage risk in all areas of a senior living operation. This system allows an operation to:

- Optimize risk-based strategic and business decision-making
- Identify, prioritize, and manage liability risks
- Minimize financial loss and support value creation
- Improve performance, reputation, and regulatory compliance
- Support merger/acquisition due diligence

External and internal risks facing senior care organizations are multifactorial and multidimensional, including financial, legal, regulatory, clinical, business, insurance, human resources, and technology risks. Daily factors also impact risk, including managing family and resident expectations, increasing resident acuity levels, aligning strategy with culture, controlling costs, and staffing challenges.

The Enterprise Risk Management System strategic platform is a powerful tool to systematically manage internal and external risks by understanding key risk drivers; event probability; and the severity impact of the risks on property, business, and human resources. The senior care Enterprise Risk Management System assists with the assessment of risk in the following areas of business: Operational, Clinical, Environmental, Legal/Regulatory, Human Resources, Technology, Financial, and Strategic.

Pendulum Enterprise Risk Management System benefits:

- Provides a management platform to quantify and prioritize system risks
- Includes project prioritization and tracking tools
- Suggests programs, systems, and strategies to manage risks

The Enterprise Risk Management System uses heat maps to illustrate the risk of each category, incident, or strategic program; the priority of risks; and the risk tolerance of the organization. A Gantt chart and calendar support program timelines and deadlines.
